Ice Surface Board Advertising

The Town of Hanna agrees to lease an agreed section of arena ice board space on an October-March seasonal basis and will renew automatically and remain on file until such time as you contact us for it to cease. Rates will be determined by Town of Hanna Council as needed.

The business is responsible for the cost of making the sign.

- Advertising to be placed on a *Styrene* type thin very pliable surface material
- Height - 33 inches
- Width – depends on available area for width measurement
- This advertising may be installed mid-season if needed



The Town will be responsible to install the ice board sign and to remove the board sign in the event that the advertising space is not renewed or paid for. If your board sign is removed after the bill due date, you have 30 days to pick your board sign, otherwise it will be destroyed.

Wall Board Sign Contract Information

The Town of Hanna agrees to lease a 32 square feet section of wall space on the Arena wall on a January – December yearly basis and will renew automatically and remain on file until such time as you contact us for it to cease. Rates will be determined by Town of Hanna Council as needed.

The business, in consideration, agrees to pay the Town of Hanna a lease fee to be set annually and payable as noted on the invoice. During the first year the sign is installed, the rental will be prorated. The rental for the season is \$300 plus \$GST.

The business is responsible for the cost of making the sign. The sign shall be of professional quality, as determined by the Town and measure 4 feet x 8 feet x approximately 1/4" (**preferably alu-paneling**) unless otherwise agreed upon by both the Town of Hanna and the business. (Chloroplast is not acceptable)

The Town will be responsible to erect the sign and to remove the sign in the event that the advertising space is not renewed. If your sign is removed after the bill due date, you have 30 days to pick your sign up, otherwise it will be destroy
