1. Solar Project at Hanna Airport:

- **Engagement with Local Pilots:** I met with local pilots to gather their feedback on the proposed solar project at Hanna Airport. Their primary concerns are centred on potential unintentional safety impacts.
- **CanWest Air Feedback:** I contacted CanWest Air for their input, particularly on the project's effect on medevac services. They provided feedback through Alberta Health Services, which was forwarded to council members.
- **Special Areas Board:** I also met with the Special Areas Board, which has confirmed its intent to register as an intervener for this project.

2. 2 Avenue Infrastructure Project:

- The project remains on schedule with a revised substantial completion date of **October 31, 2024**, and completion by **November 15, 2024**.
- Key activities include installing paving, installing curb and gutter, and upgrading utility. Minor construction damages have been addressed, and ATCO Electric has relocated light poles as required.
- Work continues over weekends to ensure deadlines are met.

3. AB Munis Fall Convention and Trade Show:

• I attended the Alberta Municipalities Fall Convention in Red Deer, which provided valuable insights into municipal governance and networking opportunities.

4. Hanna Seals Swim Club Meeting:

• Met with representatives from the Hanna Seals Swim Club to discuss their grant application for new diving blocks at the pool. The current blocks are over 16 years old. They are seeking support from the Town for this project.

5. Harvest Sky Animal Rescue:

• Met with a representative from Harvest Sky Animal Rescue to discuss ways the Town can support their operations, particularly in terms of volunteer recruitment and promoting the organization.

6. Fire Department Service Awards:

• Attended the Fire Department Service Awards to honour the dedication and contributions of our local fire service members.

Background

The Town of Hanna is reviewing its Animal Control Bylaw to consider the possibility of allowing urban hens within town limits. This process began in 2017 when Council was approached by a resident. At the time, the existing Animal Control Bylaw, established in 1993, prohibited keeping fowl within town boundaries.

After years of intermittent discussion, the topic resurfaced in 2023, prompting the development of a draft Animal Control Bylaw in 2024, which includes provisions for urban hens. The new bylaw modernizes regulations and proposes a framework for raising hens, pending public engagement and Council review.

Bylaw 1035-2024 the Animal Control Bylaw was given first reading on May 14, 2024.



Public Engagement

In June 2024 Council was presented with a draft Public Engagement Plan from the Director of Business & Communication, Laurie Armstrong. This plan was approved by Council with modifications to the timeline presented. Council wanted to delay the process until early fall when it was most likely to capture more attention from residents. A four-phase dynamic approach was used to provide the foundation for the Communications Plan. This approach was approved by Council when they approved their Public Engagement processes.

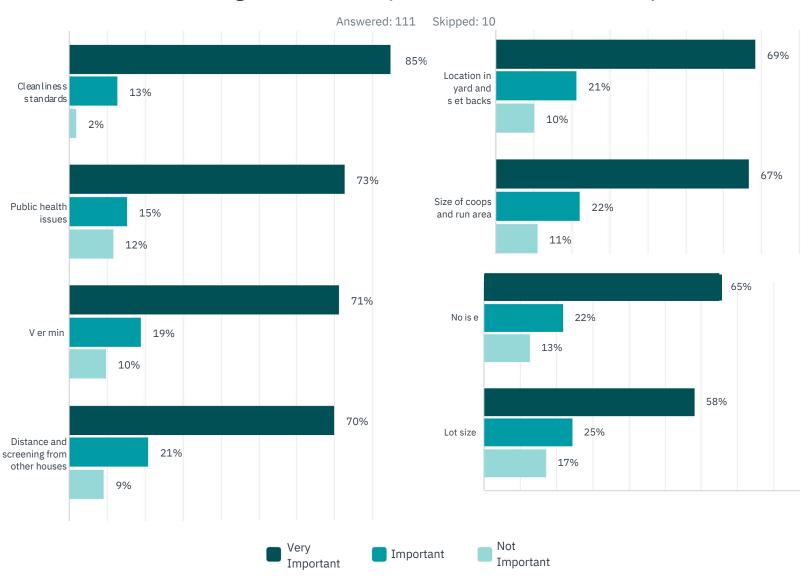

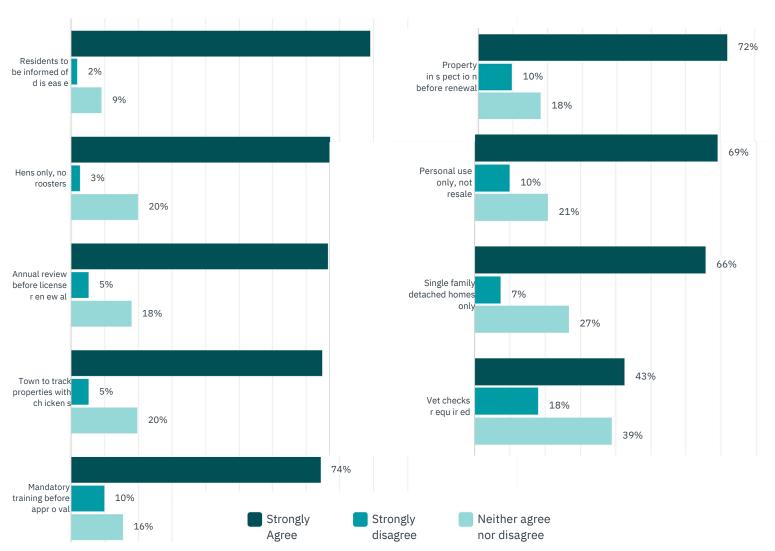


Q3 Do you think Hanna residents should be allowed to keep chickens (laying hens) within Town limits under certain guidelines?

While this may seem a great idea to many, without any foreseeable problems, I totally disagree to allowing this to occur in the township of Hanna AB.

We are living in a Northern climate which means there must be suitable housing to keeping the birds safe from the cold during winter months. That means we will allow for small heated sheds in the back yards of those choosing to keep chickens. That means there must be regulations on what is acceptable in a shed (measurement of size) & safe heating units and light(s)/switches as needed. There is the risk of fire hazards while in use. Will these sheds be inspected by a fire marshal to get accepted and approved?

There is also the need to ensure these birds are indeed keep safe. Are cared for in the manner needed, in acceptable feed(s) and a fresh water supply. How often would there be a check on their keeping in a year and who would do that?

There is also the acceptable used & disposal of manure. Can the owner use the raw manure in their gardens or would they be required to bag & dispose at the local dump? What if the manure is allowed to sit for long periods smelling up the back yard as well any adjacent properties? In the dead of winter the amount of manure may grow until spring thaw and what would be the requirement for manure removal? Who would regulate this?

#1. If my neighbours all decide to get urban hens, how will this impact the resale value of my property? Has anybody done any research into this. My property value in this town has dropped at least \$100,000 in the last 10 years. It's hard enough trying to keep property values up, and now you want to put chickens next door. So, when a potential buyer for my property shows up to view my place, and we're sitting outside in the back patio having an ice tea, and a nice big quaff of chicken manure floats by our noses, how much is that going to hurt my sale. I bought my house in this town, because it was in this TOWN, not beside a barnyard. I know all the excuses about the bylaws that will be in place regarding the maintenance of the coops and the disposal of the manure. I also know how well the bylaws regarding dogs work in this town. Bylaws in this town basically haven't been enforced in the last 10 years. Take a drive around town, look at how many vehicles are parked on the wrong side of the road, how many alleys are partially blocked with trailers and RV's. A holiday trailer on 1rst Ave. Was tagged with a warning tag almost a month ago. Three days later the tag was ripped off, the trailer is still parked there, not hooked up to anything, never mind being moved. They park a truck in front of it to make it look good, but it's not hooked up.

If we are updating our bylaws to enable ur local want a be farmers to have chickens in town, then why don't you include bylaws for cats. There are far more towns and cities in Alberta that have cat bylaws, than there is that have chickens.

To whom it may concern:

I am writing this letter to propose an initiative for an Urban hen pilot project for the town of Hanna, AB. This project would allow citizens of the community, like myself, who have a passion to build a "greener", more self-sustainable lifestyle to help return to a more meaningful and simple way of life that reaps the rewards on a deeper level between man and nature.

The domestication of poultry took place thousands of years ago. Many people feel "tied" to supermarkets and with the imploding inflation, a once affordable food source has turned into an unfortunate expense, even for the average person. It is becoming increasingly difficult to purchase basic healthy food sources on a budget due to economic strain.

Many communities and cities have allowed or are beginning to allow residents to have poultry on the property. One such city is Edmonton, AB. "The goal of the pilot project was to further understand the impacts of urban hens to determine good husbandry principals within urban context." The pilot program started in late 2014 with 19 sites and continued for the next 2 years. On March 7, 2016, the city of Edmonton extended the project for another year and increased the total number or urban hen keeping licences from 19 to 50. Limitation has been lifted effective May 2019, allowing residents to have hens so long as they follow bylaw guidelines and licencing requirements. For more information regarding their program, I encourage you to visit the city of Edmonton website to review their information regarding their Urban hen project program.

Another such city, is the city of Lacombe, Ab. The city of Lacombe's Bylaw 469, which was brought in on June 28, 2021, allows residents to keep hens on their property. With any pilot project specific terms and conditions must be met before permits are issued to approved applicants, to ensure a safe, humane and enjoyable experience. Again, if you have questions or concerns, I would encourage you to visit Lacombs website to get more details or information about their specific program. Other such locations with similar Bylaws include:

Whitehorse – residents allowed up to 6 hens.

Vancouver – allows maximum 4 hens per lot.

Victoria – has no backyard chicken limits, but the number of chickens must be consistent with the Residents personal egg use.

Self-sustaining practices support human and economic health along with vitality without compromising future generations and depleting natural resources. Consider the following benefits of the Urban hen project:

1. Chickens lay eggs which are a healthy food source.

2. Chicken manure contains nitrogen, which is an excellent natural fertilizer.

3. Urban hen project supports family activity, responsibility and learning for adults and children, helping them get involved in understanding how food gets to our table.

- 4. Great compost system. Chickens eat many food scraps that would otherwise end up in the landfill.
- 5. Bug control.
- 6. Because the program would not allow roosters, noise would be limited to cute cooing and clucking.
- 7. This program may appeal to retirees.

8. Local financial stimulation, including local hardware shops for lumber and feed.

9. Surplus eggs could be donated locally to food banks or town gatherings such as rodeo weekend pancake breakfast, for example.

10. Our country partners(farmers) who have or had chickens can be our "poultry professionals", who can provide education to those interested in raising hens.

11. Local vet care is available to provide support and care if needed.

12. Local bylaw officers can help deal with concerns as needed.

In closing, a number of people from the community have shown interest and are excited about a potential prospect of an Urban hen project and would gladly support it. Thankyou for your time and consideration of this incredible opportunity of self-sustaining practices and bringing about a more simple and rewarding way of life, a harmonious connection between man and nature.

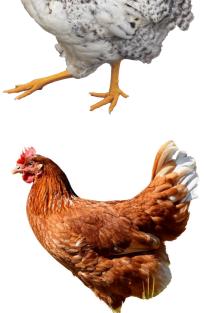
Q3. 68% of survey respondents do NOT think Hanna residents should be allowed to keep laying hens in Town limits.

Background

In 2007, the Town of Hanna received a bequest from the estate of Mrs. Freda Geuder to establish and award a bursary fund to be known as the Fred & Freda Geuder Educational Bursary for the benefit of Hanna & District students attending post-secondary educational institutions of any kind. The bursary is to be awarded to students based on need and academic standing.

Mr. & Mrs. Geuder were longtime residents of Hanna. Mr. Geuder was a businessman, owning Geuder Electric. Mrs. Geuder was a teacher and active in the community. She served as a member of Council for the Town of Hanna from 1974 to 1980.

Council accepted the donation of \$114,106.42 and appointed three trustees to establish the parameters for the bursary and determine the recipients. The funds are deposited in a separate account and accumulate interest annually. Each year, bursaries are awarded to three students in the amount of \$1,500.00 each for a total awarded of \$4,500.00. Once the 2024 award cheques are cashed, the balance in the bursary account will be \$58,249.23.

Members of the Bursary Committee for 2024, Councillor Crowle, Connie Deadlock and Audra Limpert reviewed 6 applications and awarded the following students with a \$1,500.00 bursary to continue their education:

PURPOSE

To establish the guidelines for distribution of funds from the Fred & Freda Geuder Educational Bursary.

POLICY STATEMENT

The Fred & Freda Geuder Educational Bursary was established in 2007 in response to a bequest from the estate of Mrs. Freda Geuder. The Town of Hanna was given funds from the estate and directed "to invest the said funds and the net income generated from such investments and such portion of the principal sum at their sole discretion shall be used by them to establish and award a bursary fund to be known as the "FRED and FREDA GEUDER EDUCATIONAL BURSARY" for the benefit of Hanna & District Students attending Post-Secondary Educational Institutions of any kind; and to annually for as long as possible, award such students based on need and academic standing".

RESPONSIBILITIES

Town of Hanna Administrative Services is responsible to ensure the accuracy and currency of this policy with respect to the above.

STANDARDS & PROCEDURES

In 2007, the Town of Hanna:

- Accepted funds from the Freda Geuder Estate to establish the "Fred & Freda Geuder Educational Bursary" for the benefit of Hanna & district students attending Post-Secondary Educational Institutions of any kind; and
- > Deposited the funds in a separate account to record the principle and interest; and
- > Appointed three trustees to establish the parameters for the bursary; and
- > Agreed to administer the funds to the bursary recipients annually.

Trustees are appointed annually to the Fred & Freda Geuder Educational Bursary Committee to review applications and award three bursaries of \$1,500.00 each under the parameters established by the committee.

PACE Canada Development LP has filed an application with the Alberta Utilities Commission (AUC) for the development of a 15-megawatt solar power plant within the urban boundary of Hanna, located adjacent to the Hanna Airport. The project, as outlined in the Notice of Application (Proceeding 29274), will involve 171 acres of private land and is expected to connect to the ATCO Electric Ltd. distribution system.

On December 13, 2023, Kim, at the Council's request during the November 14, 2023 Regular Council Meeting, wrote a letter to PACE Canada Development LP expressing the Town's nonsupport and opposition to the proposed Harvest Sky Solar project. This opposition was based on the potential impacts of the project on the community, particularly concerning the proximity to the Hanna Airport and its effect on emergency services, medevac operations, and flight training activities

This development may have significant implications for the town, particularly due to the proximity of the project to the Hanna Airport, potentially affecting emergency services, medevac operations, and flight training activities. The submission deadline for written objections is October 16, 2024

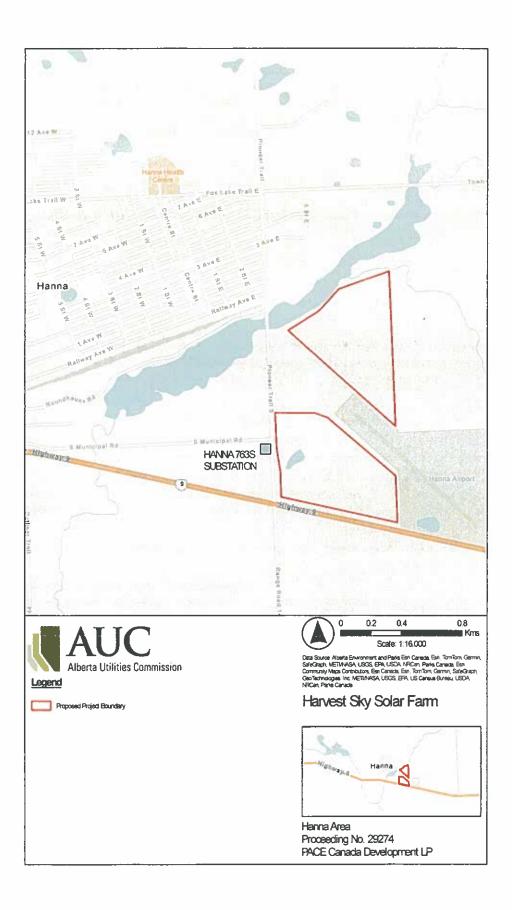

- 2. That Council directs the Administration to remove the section(s) and fees on urban hen keeping in the draft Animal Control Bylaw #1035-2024 and revise the existing Animal Control Bylaw #835 to today's standards before bringing the revisions back to Council for second and third reading.

Background

Provided, is the What We Heard Report which summarizes the public engagement that was held as well as the results of that public engagement regarding the draft Animal Control Bylaw #1035-2024.

In May 2024, the Council gave the first reading to Animal Control Bylaw #1035-2024 and requested the Administration to prepare and present a plan for Public Engagement. In June 2024, the Director of Business and Communication presented a public engagement plan. The plan included various methods of information delivery and gathering including:

- Educational pieces including a dedicated page on the Town website.
- A paper and online survey.
- A specific email address to send support or opposition correspondence to.
- A non-statutory public hearing
- The opportunity to speak directly with an elected official and/or Municipal Enforcement Officer.

Survey results and public feedback revealed that a majority of residents oppose the idea of urban hens. Specifically, 68% of survey respondents did not support allowing chickens in town. The primary concerns expressed were around cleanliness, public health, and potential vermin issues. Additionally, many residents voiced concerns about the enforcement of such regulations, given the existing challenges with animal control in the town.



The correspondence submitted and the in-person public engagement features diverse opinions from residents, with the majority opposing the inclusion of urban hens in the bylaw. Common concerns include increased risk of attracting wildlife and predators, unpleasant odours, enforcement challenges, and the potential negative impact on property values. Some residents argue that chickens belong in rural areas and fear that urban hens would exacerbate existing animal control issues, such as stray cats. However, a few residents expressed support for the initiative, citing benefits like self-sustainability, educational opportunities for families, and community involvement in sustainable practices.

As a result, the Administration recommends revising the bylaw to remove all references to allowing urban hen-keeping within the Town of Hanna and refer to the previous bylaw where fowl are not permitted within the Town. There were also some errors and sections included that are not needed for an Animal Control Bylaw that will be removed. The entire document will receive a thorough review and revision before coming before the Council again.

Background

The Town of Hanna is reviewing its Animal Control Bylaw to consider the possibility of allowing urban hens within town limits. This process began in 2017 when Council was approached by a resident. At the time, the existing Animal Control Bylaw, established in 1993, prohibited keeping fowl within town boundaries.

After years of intermittent discussion, the topic resurfaced in 2023, prompting the development of a draft Animal Control Bylaw in 2024, which includes provisions for urban hens. The new bylaw modernizes regulations and proposes a framework for raising hens, pending public engagement and Council review.

Bylaw 1035-2024 the Animal Control Bylaw was given first reading on May 14, 2024.



Public Engagement

In June 2024 Council was presented with a draft Public Engagement Plan from the Director of Business & Communication, Laurie Armstrong. This plan was approved by Council with modifications to the timeline presented. Council wanted to delay the process until early fall when it was most likely to capture more attention from residents. A four-phase dynamic approach was used to provide the foundation for the Communications Plan. This approach was approved by Council when they approved their Public Engagement processes.

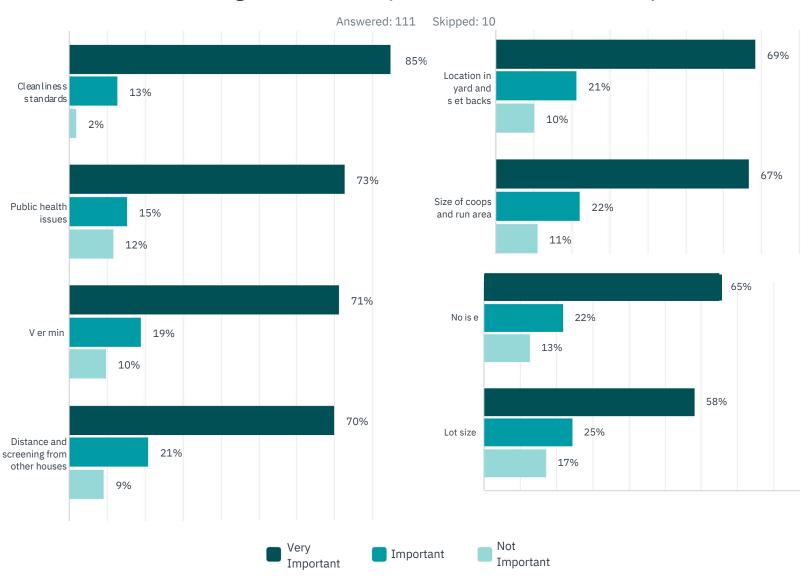

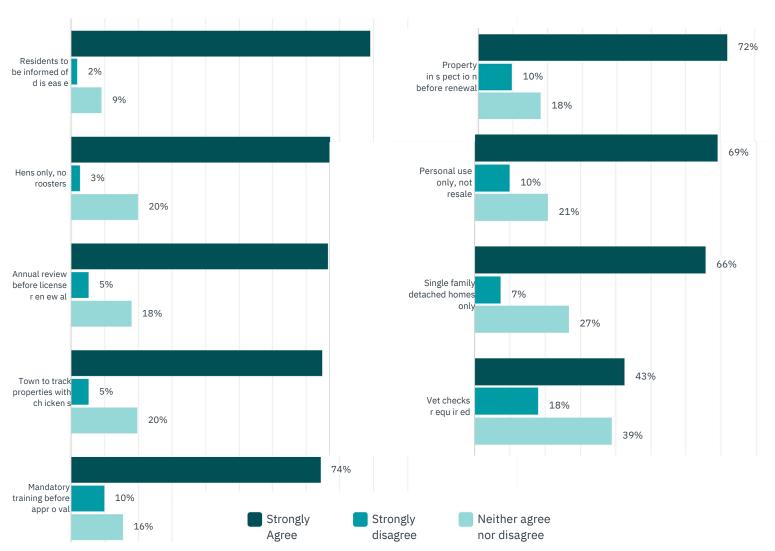


Q3 Do you think Hanna residents should be allowed to keep chickens (laying hens) within Town limits under certain guidelines?

While this may seem a great idea to many, without any foreseeable problems, I totally disagree to allowing this to occur in the township of Hanna AB.

We are living in a Northern climate which means there must be suitable housing to keeping the birds safe from the cold during winter months. That means we will allow for small heated sheds in the back yards of those choosing to keep chickens. That means there must be regulations on what is acceptable in a shed (measurement of size) & safe heating units and light(s)/switches as needed. There is the risk of fire hazards while in use. Will these sheds be inspected by a fire marshal to get accepted and approved?

There is also the need to ensure these birds are indeed keep safe. Are cared for in the manner needed, in acceptable feed(s) and a fresh water supply. How often would there be a check on their keeping in a year and who would do that?

There is also the acceptable used & disposal of manure. Can the owner use the raw manure in their gardens or would they be required to bag & dispose at the local dump? What if the manure is allowed to sit for long periods smelling up the back yard as well any adjacent properties? In the dead of winter the amount of manure may grow until spring thaw and what would be the requirement for manure removal? Who would regulate this?

To me there is too much opportunity for neglect, the need for regulations, and the risk of diseases due to poorly managed birds & manure. My property value in this town has dropped at least \$100,000 in the last 10 years. It's hard enough trying to keep property values up, and now you want to put chickens next door. So, when a potential buyer for my property shows up to view my place, and we're sitting outside in the back patio having an ice tea, and a nice big quaff of chicken manure floats by our noses, how much is that going to hurt my sale. I bought my house in this town, because it was in this TOWN, not beside a barnyard. I know all the excuses about the bylaws that will be in place regarding the maintenance of the coops and the disposal of the manure. I also know how well the bylaws regarding dogs work in this town. Bylaws in this town basically haven't been enforced in the last 10 years. Take a drive around town, look at how many vehicles are parked on the wrong side of the road, how many alleys are partially blocked with trailers and RV's. A holiday trailer on 1rst Ave. Was tagged with a warning tag almost a month ago. Three days later the tag was ripped off, the trailer is still parked there, not hooked up to anything, never mind being moved. To whom it may concern:

I am writing this letter to propose an initiative for an Urban hen pilot project for the town of Hanna, AB. This project would allow citizens of the community, like myself, who have a passion to build a "greener", more self-sustainable lifestyle to help return to a more meaningful and simple way of life that reaps the rewards on a deeper level between man and nature.

The domestication of poultry took place thousands of years ago. Many people feel "tied" to supermarkets and with the imploding inflation, a once affordable food source has turned into an unfortunate expense, even for the average person. It is becoming increasingly difficult to purchase basic healthy food sources on a budget due to economic strain.

Many communities and cities have allowed or are beginning to allow residents to have poultry on the property. One such city is Edmonton, AB. "The goal of the pilot project was to further understand the impacts of urban hens to determine good husbandry principals within urban context." The pilot program started in late 2014 with 19 sites and continued for the next 2 years. On March 7, 2016, the city of Edmonton extended the project for another year and increased the total number or urban hen keeping licences from 19 to 50. Limitation has been lifted effective May 2019, allowing residents to have hens so long as they follow bylaw guidelines and licencing requirements. For more information regarding their program, I encourage you to visit the city of Edmonton website to review their information regarding their Urban hen project program.

Another such city, is the city of Lacombe, Ab. The city of Lacombe's Bylaw 469, which was brought in on June 28, 2021, allows residents to keep hens on their property. With any pilot project specific terms and conditions must be met before permits are issued to approved applicants, to ensure a safe, humane and enjoyable experience. Again, if you have questions or concerns, I would encourage you to visit Lacombs website to get more details or information about their specific program. Other such locations with similar Bylaws include:

Whitehorse – residents allowed up to 6 hens.

Vancouver – allows maximum 4 hens per lot.

Victoria – has no backyard chicken limits, but the number of chickens must be consistent with the Residents personal egg use.

Self-sustaining practices support human and economic health along with vitality without compromising future generations and depleting natural resources. Consider the following benefits of the Urban hen project:

1. Chickens lay eggs which are a healthy food source.

2. Chicken manure contains nitrogen, which is an excellent natural fertilizer.

3. Urban hen project supports family activity, responsibility and learning for adults and children, helping them get involved in understanding how food gets to our table.

- 4. Great compost system. Chickens eat many food scraps that would otherwise end up in the landfill.
- 5. Bug control.
- 6. Because the program would not allow roosters, noise would be limited to cute cooing and clucking.
- 7. This program may appeal to retirees.

8. Local financial stimulation, including local hardware shops for lumber and feed.

9. Surplus eggs could be donated locally to food banks or town gatherings such as rodeo weekend pancake breakfast, for example.

10. Our country partners(farmers) who have or had chickens can be our "poultry professionals", who can provide education to those interested in raising hens.

11. Local vet care is available to provide support and care if needed.

12. Local bylaw officers can help deal with concerns as needed.

In closing, a number of people from the community have shown interest and are excited about a potential prospect of an Urban hen project and would gladly support it. Thankyou for your time and consideration of this incredible opportunity of self-sustaining practices and bringing about a more simple and rewarding way of life, a harmonious connection between man and nature.

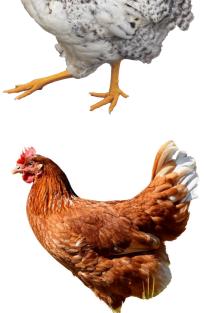
Q3. 68% of survey respondents do NOT think Hanna residents should be allowed to keep laying hens in Town limits.

Hanna RCMP lay drug charges after traffic stop

Hanna, Alta. - On the evening of Sept. 24, 2024, a Hanna RCMP officer conducted a traffic stop on a vehicle in the 600 block of 12 Avenue West. As a result of the traffic stop, the officer located a passenger in violation of a court-imposed release order requiring that he abide by a curfew, not be in a vehicle without the registered owner present, and that he carry a copy of his release conditions. The male was arrested and during a search, suspected methamphetamine was found in his possession.

39 year-old Cole Matthew Peoples, a resident of Hanna, has been charged with the following:

- Possession of a controlled substance
- Failure to comply with a condition of a release order (x3)

Peoples was taken before a Justice of the Peace and temporarily remanded into custody. Following a hearing on Sept. 25, Peoples remained remanded into custody pending his next court appearance Sept. 27 at the Alberta Court of Justice in Drumheller.

Background

The *Municipal Government Act (MGA)* says that a meeting or part of a meeting is considered to be closed to the public when

- (a) any members of the public are not permitted to attend the entire meeting or part of the meeting,
- (b) the council, committee or other body holding the meeting instructs any member of the public to leave the meeting or part of the meeting, other than for improper conduct, or
- (c) the council, committee or other body holding the meeting holds any discussions separate from the public during the meeting or part of the meeting.

Section 197 of the MGA states that councils and council committees must conduct their meetings in public unless the matter to be discussed is within one of the exceptions to disclosure in Division 2 of Part 1 of the *Freedom of Information and Protection of Privacy (FOIP)*(s. 16 to 29). This section also indicates that a council or council committee must pass a resolution stating the reason and the section of FOIP that applies before closing all or any part of a meeting to the public.



FOIP outlines the items that would allow a council to close a council meeting, which include matters where a public disclosure could be harmful to:

- Third party business interests; (s. 16)
- Third party personal privacy; (s. 17)
- Individual or public safety; (s. 18 and 19)
- Law enforcement; (s. 20)
- Intergovernmental relations; (s. 21, 22, 23 and 24) and
- Economic or other interests (s. 25, 26, 27, 28 and 29).

Public bodies should not:

- Reveal confidential employee evaluations; or
- Disclose local public body confidences, or advice from officials; or
- Disclose information that is subject to any kind of legal privilege.

For example, a discussion regarding the employment of an individual should be held incamera to protect the privacy of that individual. Also, preliminary meetings with developers (at their request/or council's discretion) describing a new land use development should be held in a closed session (s. 16 of FOIP).

The required motion to move to closed session, including the exceptions to disclosure applicable under FOIP is provided above.

The only motion allowed during closed session is a motion to move to regular session. A recommended motion is provided above.
